What is this product?

This product is a structured financial instrument with the return linked to the performance of the EURO STOXX Select Dividend 30 Price EUR Index®. The annual coupon corresponds to 2.10%p.a. if the index verifies a positive performance since inception on each Observation Date, otherwise is 0%. There is a memory feature where unpaid coupons can be recovered. At maturity, if the index verifies a negative performance since inception on the Final Observation Date, the investor will receive 95% of the invested Notional; otherwise receives 100% of the invested Notional.

Type:

This product is an unsecured debt instrument governed by English law.

Objectives:

The objective of the product is to deliver a potential remuneration based on the performance EURO STOXX Select Dividend 30 Price EUR Index®. The key risk of the product is a null remuneration if at each observation date the Reference Underlying closes below the Initial Value.

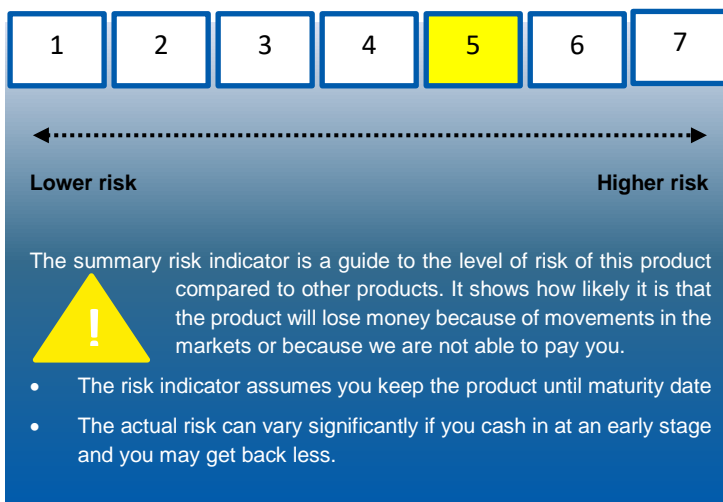
Type of retail investor to whom the PRIIP is intended to be marketed

The product is aimed at investors who:

- Have specific knowledge or experience of investing in similar products and in financial markets, and have the ability to understand the product and its risks and rewards.
- Are familiar with the Index and willing to seek exposure to it.
- Seek a product offering capital growth and have an investment horizon in line with the recommended holding period stated below.

How long should I hold it and can I take money out early
