## What is the product?

**Type:** This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

**Term:** This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

**Objectives:** This Equity Sub-fund is actively managed without reference to any benchmark aiming to achieve long-term capital growth. It invests, either directly or indirectly via shares or units of Target Funds (including exchange traded funds, ETFs), at least 80% of its net assets, in equities and equity type securities worldwide. Up to 20% of its net assets may be invested in fixed income securities, floating rate notes, convertibles and bonds with warrants of public, semi-private and private issuers with a minimum rating of BBB- at the time of acquisition. The Sub-fund invests without being limited to a specific geographic scope, industrial sector, currency or capitalization of the issuer; investments in Emerging Markets however will not account for more than 20% of the Sub-fund's net assets. On an ancillary basis, the Sub-fund may invest in money-market instruments and deposits with a maturity not to exceed 12 months. Furthermore, the Sub-fund may invest in foreign exchange options and forwards, as well as options and futures on currencies. In order to achieve its objective, the Sub-fund can use derivative instruments to protect against movements in currencies and security prices and for efficient portfolio management. The investor can buy or sell shares on a daily basis (Luxembourg bank business days). This Share Class does not make regular distributions. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

**Intended Retail Investor:** This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear an average investment loss, and a long-term investment horizon.

## What are the risks and what could I get in return?

### (A) Summary Risk Indicator



**The risk indicator assumes you keep the Product for 7 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.**

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 4 out of 7, which is a medium risk class and poor market conditions could impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product.
